#### Resumé

John qualified in pharmacology and medicine in King's College London and King's College Hospital and completed a 5-year residency in Internal Medicine in Beer Sheva, Israel. He entered the pharmaceutical industry in 1982 and served as Head of Clinical Pharmacology for The Wellcome Foundation from 1986 to 1995 and subsequently as a Director of Clinical Pharmacology at GlaxoWellcome. He continued to practise medicine and teach students on a part time basis as Honorary Senior Lecturer in Medicine at King's.
